## **Administration Services**

- Special Event Permits
  - A Special Event Permit has been approved for a Fishing Derby weigh in station on June 23 in Lyndhurst, hosted by the Kingston Avid Anglers.
  - A Special Event Permit has been approved for the Rockport Music by the River series, hosted by the Rockport Development Group. The planned dates are June 19, July 17, and August 21.
  - A Special Event Permit application is under review for the Lansdowne Fair, July 18 – 21.
  - A Special Event Permit application is under review for the Seeley's Bay Canada Day event hosted by the Seeley's Bay Residents Association.

Fire Services

- Cooperative student P. Sharpe has completed her placement with TLTI Fire and finished her Firefighter I training. She is now an active member at Station 3. The Fire Service was fortunate to have such an exemplary student, and she embodies the qualities sought after in firefighters within the Service. Fire Services proudly supports the Cooperative Program at G.S.S.
- Applications have been completed for 2024 Project Zero and Safe Community Assist. These campaigns are developed by the Fire Marshalls Public Safety Council and Enbridge Gas and are open to all Fire Departments serviced by Enbridge. Project Assist provides educational materials for firefighting, and Project Zero provides combination smoke/carbon monoxide alarms for distribution in the community for selected departments.
- SCBA testing is being completed at all stations this week.

Regional Training Center
