Fire Prevention

- Firefighters attended the Lansdowne and Seeley's Bay Public Libraries to read to the children as part of their Community Stars Program. More dates are scheduled in July and August.
- Investigation follow-up was completed for two carbon monoxide alarms at a local business.
- One campground permit was approved.
- An investigation of a fire incident at a farm property was completed.

- A meeting with the owner of a Vulnerable Property took place to discuss their Fire Safety Plan and to book a future Inspection.

Building& Planning

Public Meeting

- A non-statutory public meeting will be held on Monday, July 8, at 6 p.m. prior to the Council meeting for the property at 357 Highway 2. The purpose of the proposed amendment is to change the zoning of the subject lands from a Tourist Commercial 'CT' zone to a Tourist Commercial Special Exception 'CT-X' zone to facilitate the development of the site with a gas station, convenience store, and a restaurant with a drive-through. Zoning relief is requested to recognize the proposed width of the driveway access from Days Road, permitting a commercial patio adjacent to a residentially zoned property and permitting an advertising sign at less than 7.5 metres from a street line.
