Administration Services

- A Special Committee of the Whole and Council meeting is scheduled for Monday, July 22nd at 6:00 p.m. in Lansdowne Council Chambers. The purpose of the meeting is to consider a request for the use of a portion of the unopened road allowance, south of 418 County Road 32 to access a landlocked lot.
- The Township of Leeds and the Thousand Islands has granted an exemption to Noise By-Law 22-049, Section 2, Subsection 2 to the Live Music by the River taking place at Rockport Customs Dock for the day of July 17, 2024 from 6:30 p.m. to 8:30 p.m.

Fire Services

- The new Tanker 12 has arrived at Station 1. Members will train and load equipment over the next week to prepare to place it in service.
- The Fire Chief attend the AGM for Victim Service of Leeds and Grenville.

Regional Training Center

- The final weekend of the NFPA 1072 HazMat Operations course is scheduled for July 13-14, with Awareness and Operations exams being conducted on the 14.
- The Office of the Fire Marshal will conduct Training Portal onboarding sessions for their new Learning Management System. The Leeds Regional Training Center will host one of these sessions on July 18 for UCLG departments.
- Firefighters Without Borders Canada donated equipment for the upcoming Women of Fire event at the Leeds Regional Training Center.
