Fire Services

- Fire Services responded to 11 incidents: 4 activated fire alarms, 2 motor vehicle accidents, 2 medical calls and 3 medical calls which required a boat response on the river.
- Training was provided by Commercial Fire Equipment for Tanker 12.
- Firefighter Kirkby participated in and provided instruction at Camp Molly Lake Country, which was hosted by Orillia, Rama, Ramara, and Severn Fire departments. Camp Molly is a specialized camp aimed at empowering girls with an interest in firefighting and emergency response. These camps offer hands-on training in firefighting techniques, first aid, emergency response protocols, and teamwork skills. Participants could interact closely with female firefighters and other professionals in the field, gaining valuable insights and inspiration for potential careers in firefighting or related fields. This unique and empowering experience has a lasting impact on the young participants, fostering confidence, skills, and a sense of community.

Regional Training Center
