Public Meeting

 A public meeting will be held at 6 p.m. on Monday, March 3, 2025, regarding an application to name a private lane, which is currently the driveway from Front Street into the Hucks Marina Property in Rockport. It is proposed that the laneway be named Scenic View Lane.

Reminder to License Dogs

- All dogs over the age of 12 weeks are required to be licensed by the Township. Dog
 tags can be purchased at the Township office or requested through the <u>Ask a</u>
 <u>question portal on the Township website</u> and by sending a self-addressed
 envelope to the Township office with the required payment.
- Why do I need a dog tag?
 - If a dog is found at large without a dog tag, By-law Enforcement will not know where the dog is to be returned to and the dog is then taken to the Kingston Humane Society. The owner then must pay an impound fee, purchase a dog tag, and pay any additional veterinary fees to get their dog back. The Township may also issue a fine for failure to license a dog or a dog at large.
- What if my dog is found and it has a dog tag?
 - o If a dog found has a dog tag, by-law enforcement will make all attempts to get in touch with the owner or alternate contacts before impounding the dog. It is very important to make sure your most up-to-date contact information is on the dog tag registry to ensure the safe return of your pet!
